

ACTION MASTERS PISTOL CLUB, LLC.

ACTION MASTERS PISTOL CLUB, LLC (AMPC) IS A NON-PROFIT ORGANIZATION, WHOSE MISSION IS TO PROVIDE AN ALL AROUND SHOOTING FACILITY FOR THE ENJOYMENT OF LIKE MINDED SHOOTING ENTHUSIASTS. VARIOUS FORMATS OF SHOOTING COMPETITIONS MAY ALSO BE HOSTED ON THE RANGE.

AMPC IS GOVERNED BY A FIVE MEMBER BOARD OF DIRECTORS, WHOSE RESPONSIBILITY IS TO GUIDE THE EFFORTS OF THE CLUB. IN THE EVENT OF A VACANCY IN THE BOARD, THE REMAINING DIRECTORS SHALL ELECT A REPLACEMENT, BY UNANIMOUS VOTE, SO AS TO MAINTAIN A MINIMUM OF FIVE DIRECTORS AT ALL TIMES. THE CURRENT BOARD IS CONSISTED OF NATHAN CASAREZ, MIKE FOSTER, DIRON ROTAN, GARY VAUGHT AND RON WEAVER.

AMPC, IN ORDER TO FACILITATE AN ACTIVE AND THRIVING CLUB, MAY ALLOW UP TO 50 AT LARGE MEMBERS ON AN ANNUAL BASIS. ANNUAL MEMBERSHIP DUES SHALL BE \$250.00 (REVIEWABLE ON AN ANNUAL BASIS), PAYABLE IN FULL. FAILURE TO PAY DUES IN A TIMELY MANNER MAY BE SUBJECT FOR MEMBERSHIP LOSS. A MEMBERSHIP SHALL INCLUDE THE MEMBER, HIS OR HER SPOUSE, ANY SCHOOL AGE CHILDREN LIVING AT HOME AND GRANDCHILDREN. AMPC ALSO HAS A GUEST POLICY THAT IS NECESSARILY AN HONOR BASED SYSTEM BY THE MEMBERS. AMPC WISHES TO PROMOTE SHOOTING ENJOYMENT AND UNDERSTANDS THAT AN "OCCASSIONAL" GUEST IS CERTAINLY A MEANS OF DOING SO. RATHER THAN GO INTO A LONG LISTS OF WHO MAY AND WHO MAY NOT COME, WE ASK EACH MEMBER TO BE RESPONSIBLE FOR THEIR ACTIONS. IF YOU ARE UNSURE OF WHETHER OR NOT TO TAKE SOMEONE OUT, SIMPLY ASK FIRST. HOWEVER, EVERY MEMBER IS SOLELY RESPONSIBLE FOR THE SAFETY AND CONDUCT FOR THEIR GUESTS. EVERY ASPECT OF RANGE SAFETY WILL BE EXPECTED TO BE STRICTLY ADHERED TO. IT SHOULD BE CLEAR THAT THIS IS A PRIVATE CLUB AND IF IT IS APPARENT THAT THIS GUEST POLICY IS BEING ABUSED, DISCIPLINARY ACTION, FROM VERBAL WARNING TO MEMBERSHIP LOSS MAY BE WARRANTIED. JUST FOR AN EXAMPLE; MANY OF THE CLUB MEMBERS ARE SPECIFIC COMPETITION ORIENTED SHOOTERS. CONSTANTLY BRINGING LIKE MINDED COMPETITORS TO PARTICIPATE IN PRACTICE ON OUR FACILITY IS NOT IN THE BEST INTEREST OF THE SPIRIT OF AMPC. SIMPLY SAID, TAKE PRIDE IN THE YEARS OF WORK THAT HAS GONE INTO THE CREATION OF THIS FACILITY AND APPRECIATE THE FACT THAT YOU HAVE ACCESS TO IT. IN SO DOING, THE CLUB AND IT'S HERITAGE WILL BE ENHANCED, MAKING EVERY MEMBERSHIP MORE VALUABLE AND THE CLUB MORE CAPABLE.

THERE ARE A NUMBER OF RANGE NOTICES AND GUIDELINES THAT EVERY MEMBER MUST BE AWARE OF. FIRST AND FOREMOST IS RANGE SAFETY! AMPC IS A "COLD RANGE", THAT IS NO FIREARM IS TO BE LOADED UNTIL SUCH TIME AS YOU ARE ON A DESIGNATED SHOOTING LINE AND IT HAS BEEN TOTALLY MADE CERTAIN THAT IT IS SAFE TO LOAD AND MAKE READY TO FIRE. EYE AND EAR PROTECTION ARE MANDATED FOR EVERYONE ON THE RANGE, DURING ANY LIVE FIRE ACTIVITY. EVERY MEMBER IS REQUIRED TO MAINTAIN A VIGILANCE FOR THIS IMPORTANT SAFTEY CONCERN. IT IS THE MEMBERS' RESPONSIBILITY TO MAKE CERTAIN THAT THE RANGE IS SAFE BEFORE COMMENCING SHOOTING. ALL SHOTS ARE TO BE FIRED IN THE DESIGNATED DIRECTION THAT THE SPECIFIC VENUE BEING UTILIZED IS DESIGNED TO SHOOT, NO CROSS FIRING. ON THE LONG RANGE RIFLE COURSE ESPECIALLY, THERE IS DEFINITE NEED TO ASCERTAIN NO ONE HAS INADVERTENTLY ENTERED THE SHOOTING AREA.

THE RANGE HAS A VAST ARRAY OF TARGETS AVAILABLE TO SHOOT. GREAT TIME, EXPENSE AND EFFORT HAVE GONE INTO THE AQUIRING AND CONSTRUCTION OF THESE TARGETS. MANY, IN FACT MOST OF THEM ARE CALIBER SPECIFIC. THERE ARE A LARGE NUMBER OF 22 RIMFIRE ONLY, THESE TARGETS ARE NOT TO BE FIRED AT WITH ANY CENTER FIRE GUN, 17 RIMFIRE OR MAGNUM CALIBERS! THEN THERE ARE SEVERAL CENTERFIRE PISTOL ONLY TARGETS, THESE TARGETS MAY BE SHOT WITH RIMFIRE (INCLUDING 17 HMR AND MAGNUM), BUT ABSOLUTELY NO CENTER FIRE RIFLE CALIBER OF ANY TYPE! THEN THERE ARE RIFLE ONLY, THESE TARGETS MAY BE SHOT WITH RIMFIRE, CENTER FIRE PISTOL OR RIFLE. HOWEVER, RIFLE BULLETS MUST BE LEAD CENTER, NO ARMOR PIERCING OR SOLID STEEL AND VELOCITY IS TO NOT EXCEED 3200 FPS! FOR THOSE WITH HOTRODS LOADS, THERE ARE "JUNK STEEL" TARGETS AVAILABLE, THAT CAN BE PUT OUT FOR YOUR ENJOYMENT. THE DESIGNATED RIFLE TARGETS ARE SUBJECT TO DAMAGE, IF NOT CORRECTLY ADDRESSED AND THEY COST THE CLUB THOUSANDS OF DOLLARS! IF YOU ARE UNSURE OF A PARTICULAR TARGETS DESIGNATION, DON'T SHOOT IT!!!! IF YOUR PARTICULAR LOAD FALLS WITHIN THESE GUIDELINES AND, UPON SHOOTING A TARGET, YOU DISCOVER IT HAS DONE DAMAGE; SIMPLY PULL THAT TARGET AND BRING IT TO THE ATTENTION OF THE BOARD. NO FOUL DONE. HOWEVER, FLAGARANT DISREGARD FOR THESE GUIDELINES WILL NOT BE TOLORATED AND DISCIPLINARY ACTION WILL BE ENFORCED.

GENERAL RANGE APPRECIATION IS ASKED OF EVERY MEMBER. IF YOU SEE TRASH THAT NEEDS ATTENDING TO, OR WEEDS THAT NEED CUTTING, ETC., TAKE THE TIME TO DO SO. IF YOU SEE IMPROVEMENTS, THAT REQUIRE ATTENTION, NOTIFY A BOARD MEMBER AND ASK THAT IT BE ADDRESSED. WHEN A RANGE WORK PARTY IS SCHEDULED, MAKE EVERY EFFORT TO CONTRIBUTE YOUR TIME.

ANY MEMBER MAY VOLUNTEER TO HOST A COMPETITION. IT IS NECESSARY TO COORDINATE IT THRU THE BOARD, SO AS TO AVOID ANY SCHEDULING CONFLICT AND TO ASCERTAIN THAT AMPC IS CAPABLE OF ACCOMODATING THE MATCH. THE BOARD MAY ALSO BE ABLE TO ASSIST IN HELPING TO ARRANGE FOR ADDITIONAL CLUB MEMBERS TO BE AVAILABLE TO ASSIST IN RUNNING THE EVENT. HOWEVER IT IS THE RESPONSIBILITY OF THE INDIVIDUAL REQUESTING THE MATCH, TO COORDINATE EVERY ASPECT OF RUNNING IT. AMPC WILL DO EVERYTHING POSSIBLE TO ASSIST IN ANY WAY POSSIBLE. ALL PROPS AND EQUIPMENT OF AMPC, WHICH MIGHT ASSIST IN THE MATCH PRODUCTION, ARE AVAILABLE FOR USE. ALL PROCEEDS FROM ANY MATCH ON THE RANGE WILL GO INTO THE AMPC GENERAL FUND. ANY IMPROVEMENTS MADE TO THE RANGE, BECOME PROPERTY OF AMPC.

Liability Release
