MY NAME IS _____, I HEREBY ACKNOWLEDGE THAT I AM OF SOUND MIND AND UNDERSTAND THE INHERENT LIABILITIES REGARDING THE USE OF FIREARMS AND PARTICIPATION AT A PUBLIC SHOOTING RANGE. I FURTHER AFFIRM THAT I HAVE BEEN PERSONALLY ADMINISTERED A THOROUGH AND COMPLETE SAFETY ORIENTATION AND EXPLANATION OF RANGE RULES, BY ACTION MASTERS PISTOL CLUB (AMPC). I FULLY UNDERSTAND THE SAFETY REQUIREMENTS AND RANGE RULES AND AGREE TO ABIDE BY THEM IN THE FULLEST.

IT IS FURTHER UNDERSTOOD AND AGREED THAT I AM NOT TO SELECT OR SHOOT FROM ANY LONG RANGE RIFLE POSITION SOUTH OF THE 200 YARD SIGHT-IN BENCHES, WITHOUT FIRST TURNING ON THE “DOWN RANGE WARNING BEACON/BUZZER”. I UNDERSTAND THAT, AT NO TIME AM I TO GO DOWN RANGE INTO THE EAST “FIELD OF FIRE”, WITHOUT FIRST IMPLEMENTING THE BUZZER/BEACON.

AMPC MEMBERS ARE NOT TO KILL ANY ANIMALS ON THE RANGE PROPERTY AT ANY TIME, RATTLESNAKES ARE AN EXCEPTION TO THIS RULE. **EXTREME CAUTION IS** REQUIRED WHEN DOING SO! NEVER SHOOT AT A SNAKE WITH A HIGH POWER RIFLE! ANY FIREARM USED IS EXTREMELY DANGEROUS, DUE TO THE ROCKY GROUND AND DANGER OF RICOCHETS. IF POSSIBLE, A SHOVEL MIGHT BE BEST.

AMPC DOES NOT ALLOW AN ALCOHOL (OR NAROCOTICS) TO BE CONSUMED ON RANGE PREMISES, BEFORE, DURING OR AFTER SHOOTING IS COMPLETE, OUR INSURANCE SPECIFICALLY PROHIOBITS THIS ACTION!

BY MY ACCEPTANCE OF THIS ORIENTATION, I RELEASE AMPC, AMPC BOARD MEMBERS, CRAWFORD RANCH AND THE CRAWFORD FAMILY FROM ANY AND ALL LIABILITIES ASSOCIATED FROM MY PRESENCE ON THE AMPC RANGE, WHETHER PARTICIPATING OR SPECTATING.
