

NEW MEMBER REQUIREMENTS

IN ORDER TO ESTABLISH A SMOOTH AND CONSISTANT IMPLEMENTATION OF NEW AMPC MEMBERS, THE FOLLOWING IS PROPOSED:

1. NOTIFICATION WILL BE SENT OUT TO ALL CURRENT MEMBERS TWO MONTHS AND ONE MONTH **PRIOR** TO SCHEDULED ANNUAL MEETING.

a. THE NOTIFICATION WILL LIST THE DATE, TIME AND LOCATION OF MEETING.

b. THE NOTIFICATION WILL ADVISE THAT ATTENDANCE IS MANDATORY AND THAT FULL PAYMENT OF DUES WILL BE REQUIRED AT THE MEETING.

c. THE NOTIFICATION WILL ADVISE THAT IF, **FOR ANY REASON**, A MEMBER WILL NOT BE ABLE TO ATTEND THE ANNUAL MEETING, **THEY MUST MAKE PRIOR ARRANGEMENTS WITH A BOARD MEMBER. THAT BOARD MEMBER IS TO SO NOTIFY MIKE LOVE OF THE MATTER AND THE DUES MUST BE IN MIKE'S POSSESSION, PRIOR TO OR AT THE MEETING.**

d. FOR ANY AND ALL NEW MEMBERS WISHING TO JOIN, WE WILL INITIATE A FORMAL "WAIT LIST". THOSE PERSONS ON THE WAIT LIST WOULD THEN ALSO RECEIVE THE ANNUAL MEETING NOTIFICATION AND INVITATION TO ATTEND. A NEW MEMBER WOULD BE INVITED TO JOIN ON A FIRST COME, FIRST SERVE BASIS, BASED ON HIS/HER NUMBER ON THE WAITING LIST. BY ELECTING TO BE INCLUDED ON THE WAIT LIST, THEY WOULD BE ADVISED THAT, IN ORDER TO BECOME A MEMBER, THEY WOULD NEED TO ATTEND THE MEETING AND BE READY TO ACCEPT THE MEMBERSHIP REQUIREMENTS OF PAYMENT OF DUES AT THE MEETING. IF A "WAITING LIST" PROSPECT DID NOT ATTEND AND THE 'NEXT IN LINE' PROSPECT DID AND WAS ABLE TO MAKE DUES PAYMENT, THAT PROSPECT WOULD TAKE PRECEDENT OVER THE PROSPECT AHEAD OF THEM THAT DID NOT ATTEND OR WAS UNABLE TO FULL FILL THE OBLIGATION.

IN THE EVENT THAT THE ROSTER LIMIT OF 50 IS NOT FULLFILLED AT THE MEETING, A MASS NOTIFICATION WOULD BE EMAILED OUT TO THE WAITING LIST AND THE VACANT POSITIONS WOULD BE FILLED ON A "WHOMEVER COMPLETES THEIR DOCUMENTS AND SUBMITS PAYMENT" FIRST BASIS (BASED ON POSTMARK OF PAYMENT OR IF PAYMENT IS DELIVERED TO MIKE, IN PERSON).
